sioner of Excise.

Vide Memorandum dated 25-04-2014 [read at (ii)

above] issued by the Commissioner of Excise, following certain public perceptions as regards additional timings for sale of liquor; the Government had put on hold the process of grant of permissions for retail sale of liquor, for the purpose of consumption beyond 11:00 p.m. in all establishments includ-

ing starred hotel categories. Government further desired that a detailed procedure be prescribed for considering applications for granting permissions beyond 11:00 p.m. as per the policy of the

Government.

2. In order to stipulate a detailed procedure for this purpose, Government is pleased to constitute a Committee to go through each such case covered under Part (II) (B), in sub-part "IV. Miscellaneous", item (ii) (i) (c) of the Notification dated 28-03-2014 {read at (i) above}, headed by Additional District Collector I & Assistant Commissioner of Excise of the

District concerned as Members alongwith

- (i) Dy. Superintendent of Police & SDPO of the Taluka concerned, and
- ii) Excise Inspector of the Taluka concerned, in whose jurisdiction the proposed premises is situated.
- 3. The Committee shall consider the following aspects before recommending the application to the Commissioner of Excise for sanction, viz.—
- (a) that the licensed premises has adequate space and capacity to cater to the clientele who would be patronizing the licensed premises concerned, beyond the prescribed timings.

Sub.: Grant of Permission for Additional Timings for sale of Liquor.

Read: (i) Notification No. 1/5/2012-Fin (R&C)/ /Part file dated 28-03-2014 published in the Official Gazette, Extraordinary, Series I No. 52 dated 28-03-2014.

This space should be not less than 200 sq. mtrs. in area

- (b) that the licensed premises has adequate park-ing space outside the premises.
- (c) that the past history and criminal antecedents in respect of the applicant and the licensed pre-mises are thoroughly analyzed in respect of fre-quency of visits by anti-social elements, in-volvement in petty crimes, all other types of of-fences, etc.; which in the opinion of the Com-mittee may cause law and order situations as well as cause to lead any other offence.
- (d) that appropriate security arrangements are provided by the applicant for the security of his clientele, the staff/employee working in the premises as well as others in and around the premises and that the licensed premises has ad-equate security provisions like Closed Circuit Television Camera, separate points of ex-its and entries, etc.
- (e) that the location of the licensed premises is verified and checked, so as to ascertain the "residential status" of the licensee and to rule out any possibility that the activities during late

hours do not cause any disturbance to the residents in the vicinity.

- (f) that the applicant makes adequate arrange-ments for dropping and picking up his clients and employees and that the applicant under-takes to pay any fees for the Police services that will be provided, viz. provision of Police Picket Force at the said premises.
- 4. Based on the recommendations of the Commit-tee and after considering all other aspects as per the provisions of the Excise Duty Act, 1964, and Rules framed thereunder; the Commissioner of Excise, may at his discretion grant the permission and license for the additional timings after obtaining the prescribed fees from the applicant as provided in Notification dated 28-03-2014 {read at (i) above }.

This Notification shall come into force with immediate effect.
