Sealed Tenders are invited to dispose off unserviceable and Condemned Motorcycles/ on "As is where is basis" so as to reach the Office of the Commissioner of Excise, Panaji, upto 1.00 P.M. on 23/01/2019 (i.e. 10 Nos. Motorcycles).

Tenders will be opened in the Office of the Commissioner of Excise, Panaji, on same day at 3.30 P.M. during which period the tenderers or their authorized representatives may remain present. Tender catalogue along with terms and conditions can be obtained from the same office on all working days/hrs. on payment of Rs. 100/- (non refundable) per set from 15/01/2019 to 22/01/2019 (upto 5.00 p.m.)

The condemned vehicle shall be available for inspection from 15/01/2019 to 22/01/2019 (upto 5.00 p.m.) as per details of location mentioned in the tender catalogue.

- (a) E.M.D. will be at the rate of 25% of the quoted bid value per lot in case of disposal of vehicles/ Motorcycles and Heavy machinery/equipments etc. and disposal of furniture and other items. The same shall be in the form of D.D./Pay Order /D.C.R. of any scheduled Bank drawn in favour of Commissioner of Excise Goa, payable at Panaji and to be enclosed by all bidders along with their offer.
- (b) The balance 75% of highest bid value of each lot should be paid by the bidder within 7 days from the date of issue of sale letter/acceptance letter by the Department to the successful bidder.



This balance payment shall also be in the form of Pay Order /D.D./D.C.R., of any scheduled Bank drawn in favour of Commissioner of Excise Goa, payable at Panaji. In case of failure to make balance payment in time the amount deposited as per clause (a) above shall stand forfeited.

The Successful bidder shall lift lot(s) within 3 weeks of receiving intimation letter/Delivery order from Department and failure to do the same, then the amount deposited as per clause (b) and (c) above shall stand forfeited .

CGST/SGST will be applicable shall be payable on disposal of all condemned articles.

The Department reserves the right to accept or reject any or all tenders without assigning any reasons thereof.
